President's Report 2019-2020

It is September holidays and Melbournians are still under restrictions. The extra hour of freedom to exercise, within the 5 kilometre of our homes, has mean many visitors to Braeside Park.

Braeside Park visitation is about to pass 500,000 for September which was the total visitation for 2019.

More Parks Victoria staff has been an issue for a long time, especially when managing numerous parks. The impacts of improved visitation has made the need for more temporary signage – such as <u>No Dogs</u> as dogs in the park has increased substantially. There has been more littering and graffiti. There has been copious issues raised with ranger staff – all requiring a written response plus on ground action. There has been more access road maintenance and maintenance on access road bollards as vehicle hit these. In addition, there has been more people using the park as a toilet!

Which is probably why I walk in the Park as early as restrictions allow and why other Committee Members walk as late as restrictions allow.

I have seen a few late night revellers, possums, foxes and tawny frogmouths, sneaking home in the pre-dawn light. Our Braeside Park rabbit populations seem to have not such sense of priority and blatantly sit by or on the paths observing me. The Pobblebonk, Spotted and Striped Marsh, Southern Brown Tree and common frogs have been in full voice lately. Maybe the frog residents have learnt to utilise that early quiet period before the factories, Freeway constructors and commuters begin their daily din to advertise their presence to other frogs in the Park. The early birds, Magpies, White-Plumed Honeyeaters, Kookaburras and Ibises, all seem to enjoy a pre-dawn sing-song before the noisy human neighbours take over. Black Pacific Ducks, especially after rain, appear to like early morning strolls around the Park as I have exchanged greeting with the few crossing the paths near the Visitors' Centre.

I love the smell of early morning in the Park – the sweet fragrance of wattle and swamp melaleuca mixed with pine-like, slightly smoky smell of the cypress and overtones of fresh bread!

Very, very occasionally I encounter another human being. One regular rider dips or turns off his light when I appear and mumbles through his mask, "good morning".

Pre-dawn in the Park is a delight, which I selfishly do not want to share.

the economic recession of 1929, and not completed until 1940. Another important remnant of this period is the red brick building at the end of the Cypress Drive, the former pumping station and other buildings, saved from the path of the Mordialloc Freeway and an important part of Braeside Park, now the Park Office. Parks Victoria is updating the Park Precinct Plan with an update shortly. The water body is the training area for Phar Lap and other equine residents in the past when Harry Telford trained his stable of horses at Braeside. Known also as 'Phar Lap's Swimming Pool.', on the Racecourse training track. We plan to get more photos to show other aspects of Braeside Park highlighting the agricultural background for the next issue.

Articles of the Month

Friends of Braeside Park

Singapore with an area slightly larger than Westernport Bay and a population of 5.5 million boasts about its green lungs (parks) and being clean and green. Its new mascot is an otter, which can swim in the harbour! Victoria's animal logo, Leadbeater's Possum is critically endangered because of habitat loss. This possums nest in the hollows of old trees (150-200+ years), which are logged by VicForests or burnt in bush fires which happen where people live. Victoria's forest-lungs are regularly logged and burnt by its Government. We burn brown coal to provide energy for our increasing population. (A fine 1920's technology once celebrated for giving East Germany its distinctive atmosphere.) We fill large holes with our waste. No one would call Garden State Victoria clean and green. However, Victorian citizens see the need and are ready to take up the challenge. What is lacking is Governmental leadership.

- * The Andrews Government's election policy 'Our Environment, Our Future 2014' claimed Labour "has a long history of extending our national parks and reserves" which is where it then remained. In the Time of Covid-19, the Andrews Government is exposed as tracking as the worst performer in terms of park creation in the last 60+ years - only 6.55 ha per day in office.
- What can Mr Andrews and his government do to boost the economy and tackle the deficiency of open space in Melbourne? Well, the Chain of Parks across South Eastern Melbourne as proposed by Kingston Council would be a very good place to start.
- * The plans are already in place.
- * Two major regional parklands: Karkarook Park and Braeside Park linking a Chain of Parks was proposed by Kingston Council as far back as May 1994 and is still the core of their vision in their Stage 2 Open Space Strategy 2020.

Friends of Braeside Park (cont.)

- * There is core area of 355 hectares (the size of about 150 MCGs) of publicly owned land to create continuous park "spine" from Warrigal Road, Moorabbin to Braeside Park, Dingley. There is a range of parks to complement Braeside Park and other recreation areas serving families using a threshold of 2.4ha/1000 population as a provision of open space. There could be a central pedestrian and bicycle trails/shared paths over the 10-kilometre length of the linked parks with secondary trails and links to the surrounding communities utilising a variety of reserves, sporting fields and environments to address the needs of different populations.
- * Now is the time to buy and to construct.
- * A mix of parties own the land needed to achieve the Chain of Parks idea including Council, State Government and private companies. A Public Acquisition Overlay, which identifies land to be purchased by a public authority (in this case Parks Victoria), was applied to 128.2 hectares of land needed for the project.
- * "Protecting Green Wedges, which are the lungs of our city, has been a strong priority of Kingston Council and the Victorian Government and key to that is finally moving on industrial waste operations." There is that metaphor again- green spaces acting as lungs!
- * Kingston Council has recently voted (February 17, 2020) to reject two applications by a company to extend its industrial waste operations in Kingston's Green Wedge. "The safeguarding of Melbourne's Green Wedges is far too important to be left to VCAT and we (the Kingston Mayor and Council) call on the Planning Minister to 'call in' the application and act in the best interests of the environment, our community and the integrity of the Planning system."
- * Developers, Waste Operators etc. all play Councils off against State and Federal Government legislation. What legislation!? The slight, optional Environmental Effects Act 1978 remains in force incredible! Environment Protection Agency responds when citizens identify problems but then does nothing. Community Consultation is wasting volunteer's valuable time, as the outcome are predecided.
- * Hence the construction of the Mordialloc Freeway beside Braeside Park, severely affecting the natural environment and to the detriment of community well-being. Image that space as an environmental trail for bikes/walkers now in the lock-down!
- * Hence the approval of kick-starting the economy by building two 12-storey buildings in Dandenongmore hard surfaces to increase the urban heat Island effect.
- Hence, plans for high/Medium/Low density buildings to cram in more people but where will their young kids go to play. Ask any students confined inside during the recent Covid-19 lockdown, they want open green spaces – parks and trails.
- * Each day I walk in Braeside Park for my one-hour exercise and feel blessed to have access to this space but on a sunny day, it is jam packed with families because there is nowhere else to go. Think 10, 20 years hence and the Park swamped in a wave of humanity seeking respite from rising temperatures and high-density housing...
- * What can we do? Well there is a Council election in October so why not ask the aspiring councillors when the Chain of Parks will become reality? Remember the State
- Government's Inquiry into Environmental Infrastructure for Growing Populations (email to eii@parliament.vic.gov.au) - why not suggest the Chain of Parks as planned by Kingston Council.
- * Exploring Braeside Park is a wonderful adventure but imagine having a chain of parks to explore.

Wood Structures (adsimilis Crop Circles)

During the last couple of years, I have seen a number of wood structures resembling a rough shelter in the park.

For a while, the number of these buildings remained more or less constant and predominantly in the trail heading to the duck ponds.

Since the Covid-19 restrictions, these wooden structures have started appearing all over the park. Some are quite elaborate, but others are just a few branches thrown together.

At first, I thought that these were all done by kids playing, but a closer look shows careful construction and complex stacking of branches. Some of these branches are large and very heavy, which would point at strong adults getting seriously involved.



Alternatively, we have a situation similar to the famous crop circles which mysteriously appear during the night.

Wedding Bush (ricinocarpos pinifolius)

Every year we get the pleasure of the spring walk led by Des Lucas.

During this walk we have the opportunity of viewing many different birds, trees, flowers, orchids and beautiful wedding bush. During spring between August and October this bush flowers producing a spectacle of white over a sea of green. Wedding bush is also believed to have been use by indigenous people in ceremonies.
